Minimum Charge – Cubic Capacity and Density Application	Any shipment which as tendered exceeds 350 cubic feet of carrier's vehicle will be subject to a Minimum Charge based on 4 pounds per cubic foot, at the Customer's applicable Class 150 rate, at actual 150 class.
Pickup/Delivery Service - Non-Business Hrs (8pm-6am)	150% for afterhours and weekends 200% for holidays; minimum charge of \$295
